PROPOSAL: Erection of a single storey side extension. (Certificate of lawfulness for proposed

use)

LOCATION: Woodlea, Hillcrest, Dormans Park, East Grinstead, Surrey, RH19 2NE **COMMENTS:** Dormansland Parish Council has no objections to this application.

PROPOSAL: Demolition of existing side projection and erection of two storey side/rear

extension.

LOCATION: Farindons, High Street, Dormansland, Lingfield, Surrey, RH7 6NN **COMMENTS:** Dormansland Parish Council has no objections to this application.

APPLICATION: TA/2023/1179

PROPOSAL: Demolition of existing dwelling. Erection of a replacement chalet bungalow with

new access and entrance gates. (amended description)

LOCATION: Maher Lodge, East Hill, Dormans Park, East Grinstead, Surrey, RH19 2NF **COMMENTS:** Dormansland Parish Council has no objections to this application.

APPLICATION: TA/2023/1462

PROPOSAL: Erection of rear first floor extension.

LOCATION: 106 West Street, Dormansland, Lingfield, Surrey, RH7 6QT

COMMENTS: Dormansland Parish Council has no objections subject to an assessment of the increase in size to ensure that the increase in size is proportionate in compliance with DP13.

The property has previously been extended.

PROPOSAL: Replacement of two doors with timber replacements (Listed Building Consent).

LOCATION: Apsley Lodge, Wilderwick Road, East Grinstead, Surrey, RH19 3NT

APPLICATION: TA/2023/1493/NH

PROPOSAL: Erection of single storey rear extension which would extend beyond the rear wall of the original dwelling house by 5 metres, for which the maximum height would be 2.80 metres, and for which the height of the eaves would be 2.80 metres (Notification of a Proposed Larger Home extension).

LOCATION: 99 New Farthingdale, Dormansland, Lingfield, Surrey, RH7 6RF
