**Proposal:** Demolition of the covered projection and erection of a new front porch and first floor side extension, along with external alterations.  
**Location:** 4 Prinkham Cottages, Moor Lane, Marsh Green, Edenbridge, Surrey, TN8 5QT  
**Comment:** Dormansland Parish Council have no objection to this application

**Application:** 2026/115  
**Proposal:** Conversion of detached garage to annex.  
**Location:** Lake House, Lake View, Dormans Park, East Grinstead, Surrey, RH19 2LR  
**Comment:** Dormansland Parish Council have no objection to this application

**Application:** 2026/575  
**Proposal:** Demolition of the existing buildings and erection of a detached garage and store.  
**Location:** 3 Prinkham Cottages, Moor Lane, Marsh Green, Edenbridge, Surrey, TN8 5QT  
**Comment:** Dormansland Parish Council have no objection to this application but note the loss of trees and the offer to replant trees and therefore request that the replanting of trees, in a suitable location, is made a condition of approval of this application. Please note that the application relates to No.3 Prinkham Cottages and not No.4 which appears on the planning portal.

**Comment:** Dormansland Parish Council object to this application due to its disproportionate size, contrary to DP 13, and it's setting in proximity to Lingfield Lodge Farm House, a grade II listed building as set out in the Historic Building Officer's report dated 24/06/26.

**Application:** 2026/701  
**Proposal:** Erection of a single-storey side/rear extension and associated works.  
**Location:** The Oast House, Lingfield Lodge Farm, Moor Lane, Marsh Green, Edenbridge, Surrey, TN8 5QS  
**Comment:** Dormansland Parish Council object to this application due to its disproportionate size, contrary to DP 13, and it's setting in proximity to Lingfield Lodge Farm House, a grade II listed building as set out in the Historic Building Officer's report dated 24/06/26.

**Application:** 2026/421  
**Proposal:** Conversion of existing stables to create 3 no. bedroom dwelling and associated works.  
**Location:** Land Lying To The South of The Moor House, Moor Lane, Marsh Green, TN8 5QX  
**Comment:** Dormansland Parish Council have concerns about the sustainability of this application. Occupiers of this site would be reliant on car transport. It should also be noted that the site of this application is within the High Weald National Landscape area.

**Location:** 1 River Mill, Dwelly Lane, Edenbridge, Surrey, TN8 6QA  
**Comment:** Dormansland Parish Council have concerns about the Local Design Character and openness of the Green Belt.
