<p><b>Securities.</b> Any beneficial interest in securities of a body where—</p> <p>(a) that body (to my knowledge) has a place of business or land in the Council's area; and</p> <p>(b) either—</p> <p>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which I (or my spouse/partner) have a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>

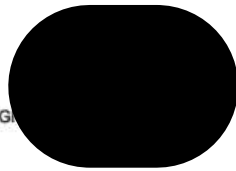
